Robust design

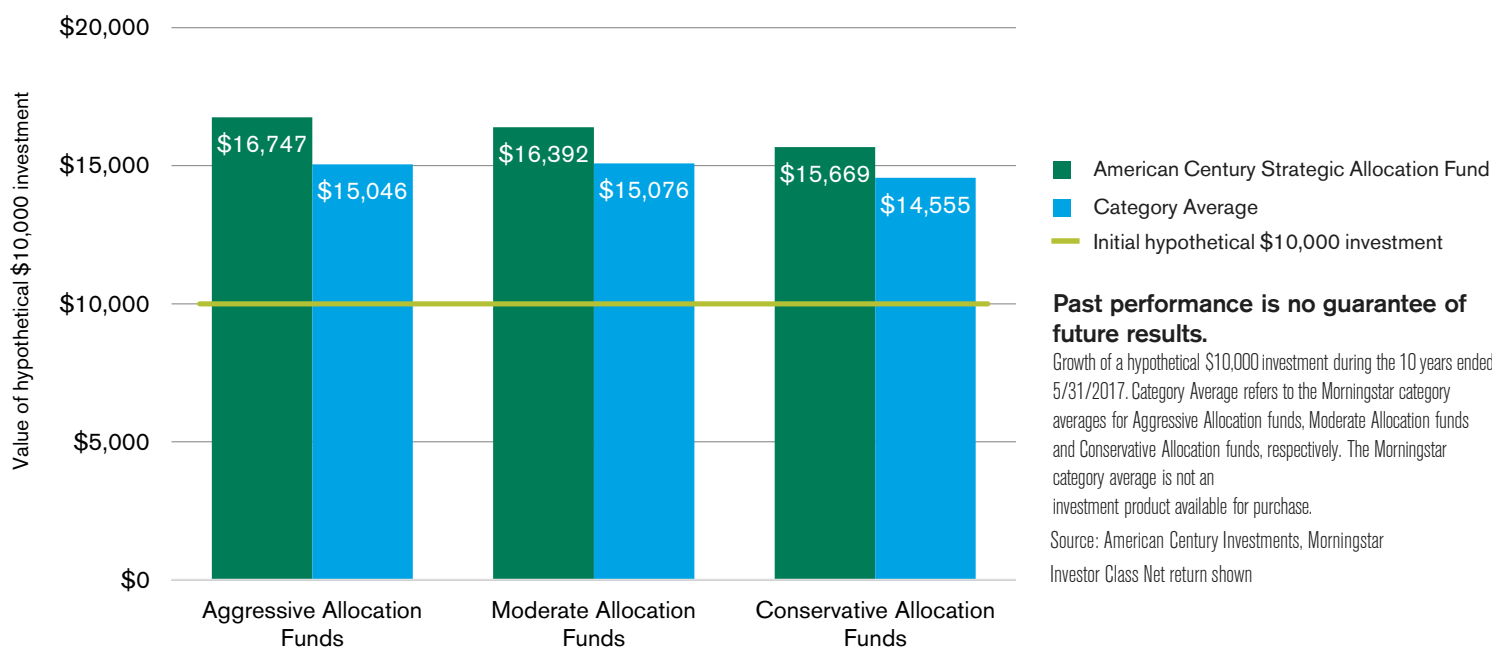

The Strategic Allocation Funds have outperformed their peer averages during the last 10 years

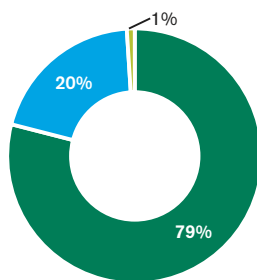


Target asset mix

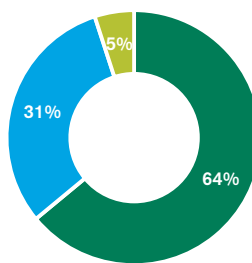

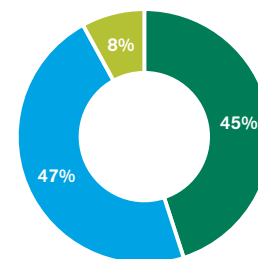
Strategic Allocation: Aggressive
